
### COVID-19 Update Tuesday, May 19, 2020

Staff Positive Cases: 12

Staff Deaths: 0

Resident Positive Cases: 38

Resident Deaths: 10



- 21 residents are on the other side of 14 days since being diagnosed.
- 6 have successfully discharged home.
- 5 are currently positive in the HCC, though this includes some residents that came to us from the hospital already positively diagnosed.
- 7 staff who tested positive are recovering and returning to work.

## **Universal Testing for COVID-19**Do residents qualify?

A few weeks ago, Governor Larry Hogan issued an Executive Order for Universal Testing in long-term care facilities.

For months, our team members have been in PPE and practicing diligent hand washing and infection control measures. In our research and our discussions with state and local health experts, we understand there is a strong possibility that we will see a rise in the number of cases in both assisted living and health care. We are prepared and have a proper staffing protocols in place to ensure continuity of care and services continue.

As of today, universal testing does not apply to residential living. Only individuals who exhibit symptoms qualify for COVID-19 testing. This would be done by contacting the resident's physician.

Residents not feeling well or experiencing symptoms such as chills, muscle pain, headache, sore throat, new loss of taste or smell, fever, cough or shortness of breath. should call their primary physician, remain at home, and contact Allison Herman, Care Coordinator, 443-605-1033.

## **Stay-at-Home Mandate Lifted in Maryland**What does this mean for residents?

Gov. Larry Hogan has lifted the stay-at-home mandate in Maryland, but at Carroll Lutheran Village, we're staying the course. **There are no changes to our current restrictions and protocols.** 



There is continued risk of COVID-19, especially for people over the age of 65 and with underlying health conditions. CEO Jeff Branch explained in his letter to families on May 15, 2020:

"As a community, we are in this together, and we need to be mindful that the decisions we make as individuals impact the health of an entire community. We encourage and advise everyone to keep this in mind as they make decisions about whether to leave the community and venture off-campus.

"For the past three months, you have trusted us to do what's best for everyone's health, safety and well-being. We appreciate everyone's support, cooperation and endless grace. This hasn't been easy.

Your health and safety remain our top priority, and we will continue to follow the directives set by national and state health agencies."

### **Preventive Measure & Protocols**

- Clinical Team members working in the Health Care Center are not providing care or service anywhere in the Independent Living or Assisted Living buildings.
- All team members throughout the community must undergo health screenings and temperature checks prior to the start of their shifts.
- All health care workers are screened and have their temperature checked prior to the start of each shift and every 8 hours.
- All staff members caring for sick patients wear personal protective equipment (PPE).
- Residents are requested to wear cloth masks when leaving their home for any reason, including picking up their mail.

 There are No Visitors Allowed, except to provide essential health care or compassionate care to residents. These essential visitors must complete a health questionnaire and have their temperature checked before entering the community.
